## Minimum Interest Charge:

## Cash Advance Fee (Finance Charge):

$\$ 10.00$ or $2.00 \%$ of the amount of each cash advance, whichever is greater. If Your Account is subject to a Cash Advance Fee (finance charge), the fee will be charged to Your Account when You obtain a cash advance from an ATM, the Credit Union or other financial institution.

## Returned Payment Fee:

$\$ 25.00$ or the amount of the required minimum payment, whichever is less. If Your Account is subject to a Returned Payment Fee, the fee will be charged to Your Account when a payment is returned for any reason.

## Card Replacement Fee:

$\$ 5.00$. If Your Account is subject to a Card Replacement Fee, a fee will be charged for each replacement Card that is issued to You for any reason.

## Document Copy Fee:

The ANNUAL PERCENTAGE RATE will never be greater than 18.00\%. Any increase in the ANNUAL PERCENTAGE RATE will result in an increase in the amount of the interest You will pay, may increase Your minimum payment, and may increase the number of payments to pay off Your balance.
